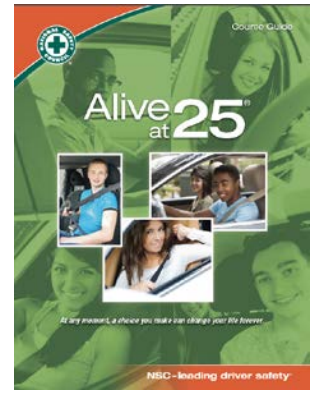




NSC Alive at 25, 4th edition

Transition Information & Course Material Pricing



Transition to the 4th edition will begin mid-November 2016. A series of Webinars will be offered to NSC Chapters, DDC Distributors, Training Center Administrators and Alive at 25 Instructors. The NSC Chapter, DDC Distributors and Training Center Administrator Webinar will be offered early November. Instructor Webinars will kick-off in December after course materials are on shelf and available to ship. Training Centers will be required to order course materials for their Instructors **prior** to attending an Instructor Webinars. It is highly recommended that Instructors have their new materials in-hands the day of the webinar.

The deadline to transition to the 4th edition is April 30, 2017. Transition pricing for existing Alive at 25 Training Centers in good standing expires on May 1, 2017. Those Training Centers that do not transition to the 4th edition by April 30, 2017, will pay retail price for the Instructor Resource Kit. No exceptions. See page 2 for pricing.

Alive at 25 3rd edition Course Materials

NSC maintains a quantity of 3rd edition Alive at 25 Course Guides that SHOULD allow enough inventory through April 30, 2017. HOWEVER, in the event that NSC depletes 3rd edition inventory of Course Guides (or any other 3rd edition Alive at 25 course materials), we will only have 4th edition course material available to purchase moving forward.

For example: XYZ Training Center places an order for 250 Alive at 25 3rd edition Course Guides on February 15. NSC has only 50 3rd edition Course Guides remaining in stock. The Training Center can purchase the remaining 50 3rd edition but the balance of 200 will need to be the 4th edition Alive at 25 Course Guide.

Alive at 25 Annual Lease Fees

The Alive at 25 annual video lease will be eliminated with the 4th edition. In order to receive the transition discount on 4th edition course materials, 3rd edition annual lease fees and instructor recertification fees must remain current and in good standing. It is highly recommended Training Centers continue to pay Alive at 25 3rd edition annual lease fees and instructor recertification fees in order to avoid paying the full retail price for 4th edition Course materials.

If Alive at 25 3rd edition annual video lease fee(s) should become lapsed, cancelled or terminated prior to the 4th edition transition, the Training Center will pay full retail price for their Alive at 25 4th edition course materials.
