- **DDC Attitudinal Dynamics of Driving** in Massachusetts — 56% decrease in traffic violations and a 63% decrease in surchargeable violations.[†]
- **DDC 4** in Nebraska — 41% reduction in recidivism; 1.7 times less likely to have another collision.[§]
