**CORPORATE HAZARD RECOGNITION AWARD**

The National Safety Council's **Corporate Hazard Recognition Award** recognizes companies, units and/or facilities that have a program in place for the prevention of workplace injuries and illnesses by incorporating hazard recognition in their safety management system.

CRITERIA:	RECOGNITION:
<ul style="list-style-type: none"> <li>• A company, unit and/or facility or an individual must have a Hazard Recognition Program in place that contains the following elements:               <ul style="list-style-type: none"> <li>○ Educating employees on the importance of recognizing hazards and their role in reporting so action can be taken.</li> <li>○ Maintains a system for employees to report hazards.</li> <li>○ Maintains a system to track hazard reporting and manage prompt corrective actions.</li> <li>○ Maintains a system to acknowledge employee participation and engagement in the program.</li> </ul> </li> <li>• <b>Bronze Award</b> honors companies that have established and maintained a hazard recognition program that contains the four elements above.</li> <li>• <b>Silver Award</b> honors companies that have an increase in the percentage of the number of hazards reported and corrected from the previous year.</li> <li>• <b>Gold Award</b> commemorates companies that have had a steady increase in the percentage of the number of hazards reported and corrected over the past two years.</li> <li>• <b>Crystal Award</b> pays tribute to companies that have had a hazard recognition program in place for the past three or more years that demonstrates a steady increase in the percentage of the number of hazards reported and corrected each year and have taken timely corrective actions.</li> <li>• Eligibility is determined based on self-reported data submitted by the participant. Any organization recording a fatality will be disqualified.</li> <li>• Organizations that have had a Hazard Recognition Program in place for multiple years may immediately apply for the award that corresponds to the level they're at.</li> </ul>	<ul style="list-style-type: none"> <li>• Qualified companies, units and facilities can purchase a Corporate Hazard Recognition Award to display their achievement at their organization.</li> <li>• <u>Pricing:</u> Engraved Plaque \$79.95 Engraved Crystal \$149.95 (plus shipping, handling and applicable tax).</li> </ul>
