2018 OCCUPATIONAL EXCELLENCE ACHIEVEMENT AWARD

The National Safety Council's **Occupational Excellence Achievement Award** recognizes companies, units and/or facilities that have reported injuries and illnesses that involved days away from work equal to or less than 50% of the BLS rating for their 6-digit NAICS code and have had no fatalities during a calendar year, January 1 through December 31, 2017.

CRITERIA:

- In accordance with the OSHA record keeping requirements, a company, unit and/or facility must have a lost workday case incidence rate (see formula below) equal to or less than 50% of the BLS rating for their reported 6-digit NAICS code during calendar year January 1 through December 31, 2017.
- Formula: Number of cases with injuries and illnesses that involved days away from work x 200,000/ employee hours worked.
- Eligibility is determined based on self-reported data submitted by the participant. Any organization recording a fatality will be disqualified.
- **Qualified applications received prior to May 31, 2018 will automatically be considered for the 2017 Industry Leader Award, however, applications received after that date will be excluded from consideration for the Industry Leader Award.**

RECOGNITION:

- Qualified companies, units and facilities will automatically receive one free personalized certificate and can purchase additional Occupational Excellence Achievement Awards to display their achievement at their organization.
