For many Texans, football season means tailgating season. This makes impaired driving a serious concern for anyone driving or sharing the road.

Remember to celebrate the season safely by planning ahead: designate a driver, catch a bus, call a cab or, if necessary, spend the night where you are.

A DWI arrest and conviction in Texas can cost up to \$17,000. Offenders must pay a long list of costs, including vehicle towing and impoundment, bail, attorney fees, court and probation fees, fees to regain or retain a driver license, and a hike in auto insurance premiums.

A lesson in school zone safety

The end of summer means millions of Texas children will soon return to school, *and likely your employees will be facing a lot more school traffic along their morning commute*. Last year, **625 vehicle crashes** occurred in school zones in Texas, resulting in **two deaths and 112 serious injuries**. The most common factors contributing to these crashes were driver inattention, failure to control speed and failure to yield the right-of-way at stop signs.

Follow these simple tips for driving in school zones:

- Put away your cell phone. **Cell phone use is banned in active school zones.**
- Pay close attention to school zone speed limit signs.
- Drop off and pick up your children in your school's designated areas, not the middle of the street.
- Keep an eye on children gathered at bus stops.
- Be alert for children who might dart between vehicles on their way to/from school.
