In 2013, the number of Texas crashes involving distracted driving totaled **94,943, up 4 percent** from the previous year.

Drivers who use a cell phone when driving are **four times more likely** to get into a crash serious enough to cause injury.

Sending or receiving a text takes a driver's eyes away from the road for an average of **4.6 seconds**. At 55 mph, that's the equivalent of **driving the length of a football field while blindfolded**.
