The National Safety Council's **Occupational Excellence Achievement Award** recognizes companies, locations or divisions that have reported injuries and illnesses that involved days away from work equal to or less than 50% of the BLS rate for their 6-digit NAICS code and have had no fatalities during calendar year, January 1 through December 31, 2023

CRITERIA:	RECOGNITION:
<ul style="list-style-type: none"> In accordance with the OSHA record keeping requirements, a company, location or division must have a lost workday case incident rate (*see formula below) equal to or less than 50% of the BLS rate for their reported 6-digit NAICS code during calendar year January 1 through December 31, 2023. <p>*Formula: Number of cases with injuries and illnesses that involved days away from work x 200,000/ employee hours worked.</p> <ul style="list-style-type: none"> Eligibility is determined based on self-reported data submitted by the participant. Any organization recording a fatality will be disqualified. Qualified applications received prior to May 31, 2024 will automatically be considered for the 2024 Industry Leader Award, however, applications received after that date will be excluded from consideration for the award. 	<ul style="list-style-type: none"> Qualified companies, locations or divisions will automatically receive one free personalized certificate and can purchase additional Occupational Excellence Achievement Awards to display their achievement at their organization.
